**Re: Report dated 01.06.2011 for sale of assets of Smt Rasila S Mehta and Smt Rina S Mehta for the purposes of distribution**

**Ref: Your letter No.840/CUS/BOM/Sale of assets of Rasila – Rina/2247-III dated June 2011**

1. I am addressing this letter on behalf of my clients Smt Rasila S Mehta and Smt Rina S Mehta to your client Custodian. Your client has on 03.06.2011 served upon my clients through me a Report dated 01.06.2011 proposing sale of their entire asset base. In Para 13 of the said Report, your client has disclosed that Smt Rasila S Mehta owns shares of Rs.319.6 crores and Smt Rina S Mehta owns shares of Rs.286.56 crores as on 31.03.2011. It is also averred that the total assets of late Harshad S Mehta, M/s Harshad S Mehta including Smt Rasila S Mehta and Smt Rina S Mehta is Rs.848.98 crores against total liabilities of Rs.19990.48 crores of these four entities. It is stated that there is excess of liabilities of Rs.19141.5 crores. Besides the aforesaid averments, your client Custodian has relied upon substantial material and Judgments.
2. In terms of Regulation No.15 of the Regulation of Special Court dated 25.01.1994 under the Special Courts Act, my clients have asked me to call upon your client Custodian as under :-
  - a) Kindly offer to my clients inspection of all the material that has been relied upon by your client and make available copies thereof to enable them to file their affidavit in reply.
  - b) Kindly furnish to my clients, the figures of liabilities of my clients which figures are not disclosed separately in your client's Report.
  - c) That as cited above, only consolidated figures have been presented by your clients in the aforesaid Report and only Exhibit C is attached alongwith the Report whereas the detailed computation of how the asset and liability picture of four entities cited therein have been arrived at is not disclosed. My clients dispute this asset and liability picture and the computations thereof as according to my clients, the assets of all the four entities have been understated and the liabilities have been overstated.

My clients are opposed to the aforesaid Report and proposes to file a reply in the time frame as stipulated under the Regulations and therefore I call upon your client to meet the legitimate requests made under this letter at the earliest. Kindly fix up the date and time for inspection on any working day by giving a notice of atleast 48 hours so that my clients can make the arrangements to depute their representative to undertake inspection.

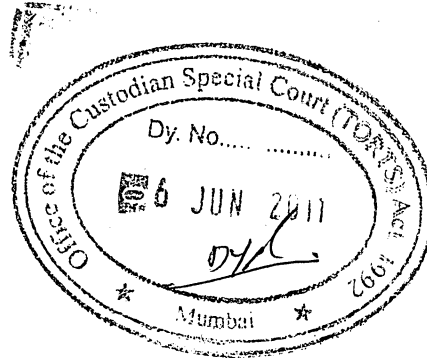
