

Please refer to your letter of the 25th February.

In the subject, we would like to mention that there is nothing in record to show that our Bank has offered you any facility to carry out on your behalf your money market transactions. The matter is under investigation by the C.B.I. and other agencies, as you are well aware. On the Bank's scrutiny Banker Shriram Dixit of the transactions, it has been observed that he had been bringing Banker's Cheque and taking Banker's Cheques against the same as well as conveying debit/credit instructions many times orally, details of which you, Shri Sitaraman and some other officials, who were at the operating end of the Securities Division at the material time, must be personally aware. It is rather astonishing that you seek details of your own transactions which are available with you.

You have also not mentioned for what period you require the Bank Statement and why, when you must be having the relevant details at your end.
