PUBLIC NOTICE CALLING FOR CLAIMS AGAINST PERSONS / ENTITIES INVOLVED IN THE 1992 SECURITIES "SCAM"

CUSTODIAN appointed under Section 3(1) of the Special Court (Trial of Offences Relating to Transactions in Securities) Act, 1992 (hereinafter referred to as the "said Act") had notified certain persons / entities for their involvement in offences relating to transactions in securities in 1992. As on date, there are 60 such "Notified Parties". The names of these notified parties are given at the end of this notice. All assets belonging to such notified parties stood attached on their respective dates of notification.

Liabilities of the notified parties are to be discharged in accordance with Section 11 of the said Act.
